SITE NOTICE

We, Inchamore Wind Designated Activity Company, intend to apply for Permission for a ten-year planning permission for development at this site at Derryreag (nDoire Aimhréidh), Co. Kerry.

The development in Co. Kerry forms part of a renewable energy development comprising a five-turbine wind farm and all associated works on lands in both Counties Cork and Kerry.

The development in Co. Kerry will consist of:

- Upgrade of existing forest access roads to include passing bays and all associated drainage infrastructure.
- Works at the entrance to an existing forest road accessed off the N22 to include localised widening of the forest road and creation of a splayed entrance, removal of existing vegetation for visibility splays and removal of street furniture.

Advisory Note: A planning application is being lodged with Cork County Council in relation to the elements of the project that are within the townlands of Inchamore, Milleeny and Derreenaling, Co. Cork. This development includes five wind turbines, underground cabling, site access roads, a borrow pit, a temporary site compound, a 38 kV substation and all associated works for which a ten-year planning permission is being sought.

The planning application is accompanied by an Environmental Impact Assessment Report (EIAR) and Natura Impact Statement (NIS). The planning application, EIAR and NIS may be inspected or purchased at a fee not exceeding the reasonable cost of making a copy at the offices of the Planning Authority at County Buildings, Rathass, Tralee, during its public opening hours and a submission or observation in relation to the application may be made to the authority in writing on payment of the prescribed fee of €20 within the period of 5 weeks beginning on the date of receipt by the authority of the application. The planning authority may grant permission subject to or without conditions, or may refuse to grant permission.

Tá sé beartaithe againne, Inchamore Wind Cuideachta Ghníomhaíochta Ainmnithe, iarratas a dhéanamh ar Chead maidir le cead pleanála deich mbliana d'fhorbairt ag an suíomh seo nDoire Aimhréidh i gCo. Chiarraí.

Tá an fhorbairt i gCo. Chiarraí mar chuid d'fhorbairt fuinnimh in-athnuaite a chuimsíonn feirm ghaoithe cúig thuirbín agus na hoibreacha gaolmhara ar fad ar thailte i gContae Chorcaí agus i gContae Chiarraí.

Is éard a bheidh san fhorbairt i gCo. Chiarraí ná:

- Uasghrádú ar na bóithre rochtana foraoise atá ann cheana féin chun bána pasála agus an bonneagar draenála gaolmhar go léir a áireamh.
- Oibreacha ag bealach isteach ar bhóthar foraoise reatha a bhfuil rochtain air ón N22 lena n-áirítear leathnú áitiúil ar an mbóthar foraoise agus cruthú bealach isteach spréach, baint an fhásra atá ann cheana féin le haghaidh spréanna infheictheachta agus baint troscáin sráide.

Nóta Comhairleach: Tá iarratas pleanála á chur isteach go Comhairle Contae Chorcaí maidir leis na gnéithe den tionscadal atá laistigh de bhailte fearainn na hInse Móire, na Millíní agus Dhoirín Álainn, Co. Chorcaí. Áirítear leis an bhforbairt seo cúig thuirbín gaoithe, cáblaí faoi thalamh, bóithre rochtana chuig an suíomh, sloc iasacht, compún sealadach suímh, fostáisiún 38 kV agus na hoibreacha gaolmhara go léir a bhfuil cead pleanála deich mbliana á lorg ina leith.

Beidh Tuarascáil ar Mheasúnú Tionchair Timpeallachta (TMTT) agus Ráiteas Tionchair Natura (NIS) ag gabháil leis an iarratas pleanála. Is féidir an t-iarratas pleanála, TMTT agus NIS a iniúchadh nó a cheannach ar tháille nach mó ná an costas réasúnach a bhaineann le cóip a dhéanamh in oifigí an Údaráis Phleanála ag Áras an Chontae, Ráth Teas, Trá Lí, le linn a n-uaireanta oscailte poiblí: Luan go hAoine 09.00 go 17.00 agus aighneacht nó tuairim a thabhairt maidir leis an iarratas. féadfar é a dhéanamh chuig an údarás i scríbhinn ar an táille fhorordaithe de €20 a íoc laistigh den tréimhse sin *5 seachtaine* ag tosú ar an dáta a bhfaighidh an t-údarás an t-iarratas. Féadfaidh an t-údarás pleanála cead a dheonú faoi réir nó d'éagmais coinníollacha, nó féadfaidh sé diúltú cead a thabhairt.
